1. Cancellation and Refund Policy

- Full Refund Deadline: Cancellations will be eligible for a full refund until **15th August**.
- Partial Refund: Cancellations made between August **16th and 30th** will be subject to a cancellation fee of 50% of the amount paid.
- Late Cancellations: **After September 1st** no refunds will be issued except in cases of documented exceptional circumstances (e.g., family bereavement, health issues).
- Registration Transfer: Registration transfer to another individual may be permitted upon prior notification, with an administrative fee, if applicable.
